Survey for children on Child Rights Mainstreaming: Tell the UN!

Deadline to respond - 30 September

Introduction story:

Sara is 12 years old and she goes to school and has a lot of friends there. On Monday, Sara sees her teacher punishing her friend Pato because he protested to end violence against children at home and at school. Later, Pato tells Sara: "I would like to be a superhero who protects children from unfair things of this world! That's why I protested, but now our teacher is punishing me." Sara doesn't understand why Pato got punished. She thinks this punishment was unfair.

While having dinner, Sara speaks about the protest & punishment with her parents. The parents of Sara get angry and tell her not to question her teacher because she knows how to educate children. Now Sara is even more upset because her parents don't understand her.

That night, Sara says: "Now, it's time to become a detective and explore this problem". Sara googles "children protesting" to find out why punishing Pato was not the right thing to do. She finds out that every child in this world has "things" which the child is allowed to have or to do. These "things" are called "children's rights" and children and adults have to respect and protect these rights. So, Sara understands why not respecting children's views was wrong! Sara is upset that many adults like her teacher and parents don't know about child rights. Even many children don't know about their own rights!

Later, she finds a page on child rights mainstreaming and reads more about the role of the United Nations (UN). She understands that everyone, including the UN, has to do more work to make sure that child rights are well-known by everyone and to convince governments to prevent situations like Pato's from happening. Now, the UN is putting some extra efforts to work on child rights by writing instructions called "the UN Guidance Note on Child Rights Mainstreaming". The UN is asking children to participate and support this process! Finally, Sara says: "I want to become a leader of this process and inspire other children. Children's rights are super important to all children in this world!" She encourages all her friends and children from the community to participate in this process.

You are not expected to already know about child rights mainstreaming and the United Nations (UN) and its work to take this survey.

Explanation for both answers: The UN is an international organisation and started its work in the year 1945. Today, the UN is made up of 193 countries (which are the UN Member States). The main task of the UN is to improve the world for everyone. The three main tasks & pillars of the UN include human rights, peace & security and development.



The UN is made up of lots of different parts with their own area of work. Some parts help to monitor and report on the work under these three main pillars or tasks, and other parts focus on specific issues (like health or environment) or groups (like children or refugees). You can watch him <u>here</u> sharing ideas on how we can all work together for a better future for our planet and humanity. He calls this 'Our Common Agenda.'


- 8. Do you know how the UN is putting child rights into action?

Explanation to both answers: The UN is working on supporting States by assessing how they promote and protect children's rights, giving them recommendations on how to do so and assisting them with projects. In addition, the UN is empowering and building capacities of various people, including children, women and refugees. Also, the Secretary-General has written about the important role of children within civil society, and the UN has agreed to make sure that children can meaningfully participate in the discussions on climate change, for instance.

Explanation to both answers: Child Rights Mainstreaming means making sure child rights are well-known to everyone (also to children), everyone is taking action and investing time & resources on child rights. Explanation to both answers: The UN Guidance Note on child rights mainstreaming is very important! Through the guidance note, the UN will say how every part of the UN can improve its work and better integrate children's rights!



The Secretary-General has already published a guidance note on children, but it was just about <u>justice</u>. There is also one on <u>civic space</u> where children are recognized as important civil society actors!
